

MORGAN WEANLING GALA SIRE NOMINATION AGREEMENT for 2019

This Agreement is by and between the Morgan Weanling Gala (“MWG”) and the party identified below (“Nominator”) for the purpose of nominating the named sire for eligibility in the Morgan Weanling Gala.

MWG was established to promote the future of the Morgan Breed by spotlighting nominated Sires and their get. MWG is and governed in accordance with the rules and policies adopted by the Morgan Weanling Gala.

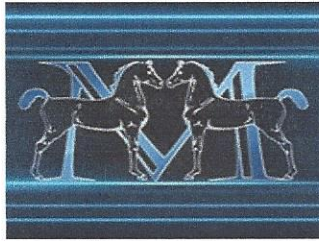
Whereas, Nominator wishes to promote the get of the sire named below and the MWG wishes to promote the Morgan breed and is organizing an event in 2019 to be known as the Morgan Weanling Gala to be held at The Jubilee Regional Morgan Horse Show;

1. Sire Nomination. Nominator nominates and MWG accepts the Morgan horse named below as an eligible sire of foals to be shown in the Gala and eligible for the SHR/MWG Performance Incentive Program.

2. Promotion of Gala and Distribution of Winnings. MWG shall organize and promote the Gala, including the offering and payment of prize money to the winning foals and sire nominators, so long as the Contingency described in Paragraph 4 below is met. The total amount of prize money paid to the Top Ten placings shall be the sum of the Sire Nomination Fees received in that year (“Payout”). The Payout is distributed among the Top Ten placings according to the fixed Percentages indicated below with a fixed amount paid to the Sire Nominator and the variable balance paid to the Weanling.

The below is an example assuming 15 Nominated Sires at \$1,950.00 each. The actual Payout Total and Payout/Placing will vary based on total actual Sire Nomination Fees received.

3. Sire Nomination Fee Schedule. In consideration of MWG's acceptance of the sire nomination and agreement to organize and promote the Gala, Nominator agrees to pay the Nomination Fee as follows:

Early Nomination Fee of \$1,950.00

If contracted by March 31, 2018

Payable as follows:

First Installment due with contract: \$ 250.00

Second Installment due March 31, 2019: \$1,700.00

If contracted by July 31, 2018

Payable as follows

First Installment due with contract: \$ 950.00

Second Installment due March 31, 2019: \$1,000.00

Late Fee of \$300.00 is applicable if not paid in full by March 31, 2019.

After July 31, 2018:

If signed and paid in full by March 31, 2019: \$2,250.00

If signed and paid in full by June 30, 2019: \$2,500.00

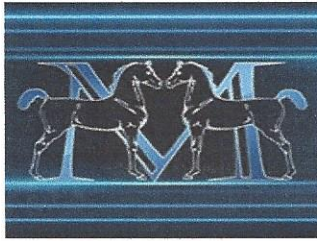
If signed and paid in full by July 31, 2019: \$3,000.00

4. Contingency. The MWG's obligation to proceed with organization, promotion, and staging of the 2019 Gala is contingent upon receipt of a minimum number of Sire Nominations by March 31, 2019 in order to insure viability of the Gala as solely determined by the MWG. In the event that that minimum number of Sire Nominations has not been received and paid in full by that date, the MWG may elect to cancel the Gala for 2019 and return nomination fees paid to date. This represents the full extent of MWG liability to any Nominator or Exhibitor.

5. Termination for Non-Payment of Nomination Fee. If a Sire Nomination Fee is not fully paid by July 31, 2019 and MWG has not elected to cancel the 2019 Gala, the nomination for that sire will be deemed void and foals sired by that nominated horse will not be eligible to show in the Gala or participate in the SHR/MWG Performance Incentive Program. Any funds already paid for that Sire Nomination will be retained without liability to MWG.

6. Entire Agreement. This is the entire agreement of the parties with respect to the Sire Nomination and production of the 2019 Gala, superseding any and all prior oral or written agreements. This Sire Nomination Agreement may be amended only in writing signed by both parties. The MWG Committee shall have no liability and no obligations except as stated in this Agreement.
